The Mackinac County Board of Commissioners held their regular meeting on Thursday, October 14, 2021 in the Courthouse Annex, 100 S. Marley St., St. Ignace, Michigan.

The meeting was called to order by Vice Chair Krause at 4:30 pm.

The Pledge of Allegiance of the United States of America was recited.

The Register of Deeds office requested from the ARPA Committee funds to complete their scanning project. The Board discussed this and agreed to approve funds from the ARPA monies up to \$90,000 to complete the Register of

The Board received a complaint regarding the Helicopter Tour business that operates out of the County Airport. The complaint states that the helicopter tours all summer causing noise by flying over the residential areas in St. Ignace. The Board will schedule a meeting with Airport Manager Paul Fullerton to resolve this issue.
