MACKINAC COUNTY PROPOSAL

Proposition for 9-1-1 System Funding

Shall the County of Mackinac, Michigan, be authorized to assess a charge on all landline, wireless, and voice over internet protocol service users located in Mackinac County of up to \$2.50 per month, being a \$1.02 increase from \$1.48 to \$2.50 per month, to be used exclusively for the funding of 9-1-1 emergency telephone call answering and dispatch services within Mackinac County, including facilities, equipment, maintenance, and operating costs.

CLARK TOWNSHIP PROPOSAL

Service Vehicles and Equipment Proposal

Shall Clark Township impose an increase of 1 mill (\$1.00 per \$1,000 of taxable value) of the Tax Limitation imposed under Article IX, Sec. 6 of the Michigan Constitution and levy it for five years, 2021 through 2025 inclusive, for the purpose of providing for vehicles and major equipment for the Clark Township Fire and Ambulance Services, raising an estimated \$202,882 in the first year of millage.

HUDSON TOWNSHIP PROPOSAL

Road Improvement Millage Renewal Proposition

Shall the expired previous voted increases in the tax lilitations imposed under Article IX, Sec. 6 of the Michigan Constitution in Hudson Township, of 2 mills (\$2.00 per \$1,000 of taxable value), reduces to 1.9756 mills (\$1.9756 per \$1,000 of taxable value) by the required millage rollbacks, be renewed at and increased up to the original voted 2 mills (\$2.00 per \$1,000 of taxable value) and levied for 6 years, 2021 through 2026 inclusive, for the purpose of improving roads in the Township of Hudson, raising an estimated \$30,780.12 in the first year the millage is levied?

NEWTON TOWNSHIP PROPOSAL

Ambulance Renewal

Shall Newton Township impose on all property in Newton Township an assessment of 1 mill (\$1.00 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution and levy it for 4 years, 2021 through 2024 inclusive for the purpose of providing funds for Ambulance Service within Newton Township, raising an estimated \$41,000 in 2021, the first year of millage?
