The Mackinac County Board of Commissioners held their regular meeting on Thursday, April 20, 2023 in Board Room Courthouse Annex, 100 S. Marley Street, St. Ignace, Michigan.

The meeting was called to order by Chair Patrick at 4:33pm.

Elected Officials/Staff Reports:

Emergency Manager Mike Kasper – flooding on west end of U.P., East Lake Road was closed due to rain and was poor road conditions. Also had fire exercise to burn an old house.

Sheriff Ed Wilk – Stonegarden grant money has doubled from last years amount. Still searching for employees. He suggested bringing the pension back to draw new employees in and retain them.

Equalization Director Mike Gillett – the Equalization is complete, and now working on the L4028. He requested to have his new hire moved up a pay step due to experience and qualifications. Treasurer Jennifer Goudreau – presented the 1st quarter financial reports. (reports attached)

Clerk Hillary Vowell - gave an update on the start of the Wage Study.

Mackinac Economic Alliance Director Chris Brynes – presented the annual MEA report and spoke on current projects. Mackinac Marine Services received a \$3,000,000 grant to transfer ferry boats to electric. There needs to be upgrades to the power grid in order to accommodate this. (reports attached)

The MEA annual contract was presented for approval. Chair Dean Reid answered some questions. The MEA no longer has physical office space and questioned if they needed workman's comp liability insurance if there was not an office with employees. The board requested that the MEA provide the county with their financial statements. Clerk Vowell was asked to send the MEA contract to the County Attorney for clarification. (contract attached)

Old Business:

Straits EMS Authority Mark Wilk – was present to discuss loan options for the remaining funds to build the new EMS building. The board looked at loaning the remaining funds to the EMS Authority. They would like to break ground very soon. It was moved by Commissioner Kaiser second by Commissioner Clark to tentively loan these funds pending any legal opinions they receive at the MAC Conference. Veterans Service Board Chair Dick Pershinske – was present to answer any questions. Discussion was had regarding the salary raise the Veterans Board had given the Veterans Service Officer. Clerk Vowell had on hand the opinion of the County Attorney they had requested at the previous meeting. The board placed a call to Attorney Bonnie Toskey during the meeting to help clarify her opinion. This matter was tabled until the May 11 meeting and Clerk Vowell will bring the salary resolution for any amendments.
