

MACKINAC COUNTY BOARD OF COMMISSIONERS PROCEEDINGS
Thursday February 13, 2025

The Mackinac County Board of Commissioners held their regular meeting on Thursday February 13, 2025 in the Annex Boardroom, 100 S. Marley Street, St. Ignace, Michigan.

The meeting was called to order by Chair Patrick at 4:30pm.

The Pledge of Allegiance of the United States of America was recited.

Public Comment:

Al Garayaglia, Brownfield Authority Member – said he is in support of previous Commissioner Jodi Kaiser being re-appointed to the Brownfield Authority. Jodi is a huge asset to the authority and she has a wealth of knowledge. He is hoping the current board will re-appoint her.

Elected Officials/Staff Reports:

Sheriff Ed Wilk – received reimbursement from 2024 for \$19,543 marine grant and \$12,700 reimbursement for corrections academy. Also having drain issues in the jail, and the lobby bathrooms are out of order. Lt Vallier was able to get a \$60,000 grant to re-model jail cell. Lt. Vallier spoke briefly about the growing need for mental health services.

Temp Equalization Director Dulcee Ranta – gave a brief update on the Equalization Office.

Register of Deeds Mary Jo Savard – interest rates are causing sales to decline currently.

Deputy Treasurer Becky Paul – requested to be paid out her longevity at pro-rated amount due to her retirement. It was moved by Commissioner St. Louis-Scott second by Commissioner Kling to approve the pro-rated longevity pay out. Roll Call: YES: Kimberling, Kling, Patrick, Schroeder, St. Louis-Scott. NO: none. Probate Judge W. Clayton Graham – there was an unexpected death of the Probate Court Public Guardian. Donna had 12-15 clients in Mackinac County that she supervised and was Guardian over. She will be unreplaceable as she went above and beyond for little compensation. Judge is asking for \$25,000 to try to find someone to fill this role. This person would be on a contract basis and 1099. There is a budget amendment that will need to be approved.

Old Business:

The board reviewed letters of support for Jodi Kaiser to remain on the Brownfield Authority. Commissioner Schroeder is interested in being appointed to the authority.

2 reclass requests that were reviewed at a Committee of Whole meeting on February 5, 2025 were presented for a decision. 1st request was for Chief Deputy Clerk position. It was moved by Commissioner Kimberling second by Commissioner Schroeder to approve the reclass to pay grade 10 step 1. Second request for the Crime Victim Advocate position. Discussion of creating the Animal Advisory Committee was had. Commissioner Kling would like to see the policy changes made at the Dept Head meeting and the board needs to move forward with the appointments to this committee. Commissioner St. Louis-Scott would like to see new waterproof dog beds purchased for the shelter. She is requesting the board to put \$400 towards the new beds. It was moved by Commissioner St. Louis-Scott second by Commissioner Kling to approve \$400 for dog beds. Clerk Vowell and Commissioner St. Louis-Scott will get the beds ordered asap.
