# MACKINAC COUNTY BOARD OF COMMISSIONERS PROCEEDINGS Thursday February 8, 2024

The Mackinac County Board of Commissioners held their regular meeting on Thursday February 8, 2024 in the Courthouse Annex Boardroom, 100 S. Marley Street, St. Ignace, Michigan.

The meeting was called to order by Chair Litzner at 4:32pm.

The Pledge of Allegiance of the United States of America was recited.

**MSU Extension Tracie Abram** – gave a brief update on the recent events. There is a new volunteer from Mackinac Island and will be starting a new class on the island with horses. There has been a small engine class in Curtis and this has been going well. Many students signed up for this and are excited to learn about engine repair.

**Veterans Board Dick Pershinske** – need to get started on the proposal wording for the Veterans Service renewal proposal soon. Clerk Vowell will get the previous millage proposals and the filing deadline to the Veterans Board.

Airport Manager Paul Fullerton sent a receipt for repairs to his plow truck. He uses his personal plow truck to plow the airport. This will be discussed at a later meeting.

Commissioner Litzner presented a proposal for new legal counsel.
