The Mackinac County Board of Commissioners held their regular meeting on Thursday January 23, 2025 in the Annex Boardroom, 100 S. Marley Street, St. Ignace, Michigan.

The meeting was called to order by Chair Patrick at 4:30pm.

**Elected Officials/Staff Reports:**

Treasurer Tina Jones-Massey – presented 4<sup>th</sup> qtr financial reports. She informed the board that Deputy Treasurer Becky Paul is retiring and she will be posting the open position.

MSU Extension Education Coordinator Traci Abram – introduced herself to the new members. She discussed some new volunteers in the St. Ignace Area and MSU will soon be offering art and culinary classes.

Prosecutor Stuart Spencer – said there has been lots of appeal cases filed, numerous victim crimes in January and many new meth related cases.

He also requested years of MERS credit to retirement. Back in 2016 the County opened MERS Defined Benefits to have elected and 1 commissioner opt in. He has requested service credit from the previous board and they denied the request. Clerk Vowell said MERS does allow the county to credit employees if they decide to. Commissioner Patrick said the portage office unit will be moved over to the old EMS site by next week. And the hospital also donated the LED light for the parking lot.

Traci Abram would like to see if she can put in raised gardens this summer at the new MSU Extension office. She said a water source is needed and if this could be installed.

Mike Williford, St. Ignace City Council Member – introduced himself and said he plans on attending more meetings. Also had a complaint about the Prosecutor not giving him any notification on a crime that he was a victim of; he said he felt he should be notified and that the prosecutors attitude towards him was unacceptable.

Treasurer Tina Massey – said Jodi Kaiser did well on the Brownfield and she agrees with Commissioner St. Louis-Scott that she should be kept on the committee.
