# Thursday, June 9, 2022

The Mackinac County Board of Commissioners held their regular meeting on Thursday, June 9, 2022 in the Courthouse Annex Boardroom, 100 S. Marley Street, St. Ignace, Michigan.

The meeting was called to order by Chair Lehrke at 4:30 pm.

The Pledge of Allegiance of the United States of America was recited.

#### **Elected Officials/Staff Reports:**

Treasurer Jennifer Goudreau also informed the board that the computer budget would need to be amended. She suggested adding an additional \$5,000 at this time.

**Sheriff Ed Wilk** – updated the board on the jail population. He said people are still traveling regardless of the high price in gas and still committing crimes. Also working with Emergency Services Manager Mike Kasper on grants for new Sheriff boat. Some discussion on the sales of the patrol cars was had.

**Emergency Services Manager Mike Kasper -** gave a covid update. Discussed boat grants for the Sheriff Dept.

**Mackinac Economic Alliance Chris Brynes** – gave an update on the ship building project and fish processing plant in Epoufette.

**Airport Manager Paul Fullerton** – discussed the County taking back Great Lakes Air. Paul will be managing the fuel sales again after Great Lakes Air is no longer involved. Fuel sales generates approximately \$20,000 annually. The

County will need to approve the contract with Phillip 66 for fuel and transfer this from Great Lakes Air back to the County. The board gave permission for Treasurer Goudreau to sign on the County's behalf. It was moved by Commissioner Patrick second by Commissioner McPhee to have Treasurer Goudreau accept this contract.
