

MACKINAC COUNTY BOARD OF COMMISSIONERS PROCEEDINGS
Thursday March 13, 2025

The Mackinac County Board of Commissioners held their regular meeting on Thursday March 13, 2025 in the Circuit Courtroom, 100 S. Marley Street, St. Ignace, Michigan.

The meeting was called to order by Vice Chair Schroeder at 4:30pm.

The Pledge of Allegiance of the United States of America was recited.

Old Business:

Lester Livermore, Animal Advisory Committee Chair – spoke on the recent meeting. The committees' by-laws were approved and they need final approval from the Board of Commissioners. There are lots of talented and committed people on this newly formed committee. And they are off to a great start. The committees' meetings will be the 1st Thurs of each month at 5:30pm in the Annex Boardroom. Commissioner St. Louis-Scott brought 2 additional letters of recommendation for the Animal Advisory Committee. There are also 2 members that were appointed that would like to resign. This was tabled until the Board receives the letters of resignation. It was moved by Commissioner Kimberling second by Commissioner Kling to table the appointment of 2 new members until the Board receives the 2 letters of resignation. VVMC

The Board of Commissioners received a letter from the Veterans Committee requesting the county have a single audit to track the Veteran's millage monies previously back when it was in the County's general fund and to the current; now that it is a separate fund of their own. Since the meditation agreements between the Board and the Vet Committee were not kept; the Veterans Committee would like to see the financial reports just to have some clarification. It was moved by Commissioner Kling second by Commissioner St. Louis-Scott to authorize a single audit from 2018-present not to exceed \$5000. Letter of appointment to the Snowbelt Transit Commission was discussed. Not much info is known about this committee at this time. It was moved by Commissioner Kling second by Commissioner Kimberling to table this until further info is received. VVMC (letter attached)

Application for SSM Tribe of Chippewa Indians 2% monies was received by Top of the Lake Snowmobile Museum in Naubinway. This is pass thru money that the applicant receives if approved. The money is sent to the County and in return the County cuts a check for the applicant. It was moved by Commissioner Kimberling second by Commissioner Kling to approve the request. Commissioner Kling discussed the Veterans Committee Per Diem being paid out of the 276 special millage fund. It was discussed that no other County committees are paid out of a special fund but rather paid from the County general fund. It was moved by Commissioner Kling second by Commissioner Kimberling to move Veterans Committee Per Diem payments out of the 276 fund and into the general fund. Commissioner St. Louis-Scott - Opioid Committee has not had much attendance lately. And she met an Insurance Rep that has over 30 years' experience in the insurance industry and would like to meet with the Insurance Committee.

Commissioner Kling - policy meeting went well. And they are looking at software for the creation of policies.

Commissioner Kimberling - Sheriff contract was approved by the Officers. And also, Moran Township currently does their own land divisions. This was previously discussed.

Commissioner Schroeder – first Dam Committee meeting soon.

Clerk Vowell asked the members if they wanted to attend the Enbridge Tour scheduled for Tues. March 18.
