# MACKINAC COUNTY BOARD OF COMMISSIONERS PROCEEDINGS

# Thursday, March 22, 2018

The Mackinac County Board of Commissioners held their regular meeting on Thursday, March 22, 2018 in the County Annex Building, Board Room, 100 S. Marley St., St. Ignace, MI.

The meeting was called to order by Chair Patrick at 4:30 pm.

The Pledge of Allegiance of the United States of America was recited.

Roll Call: Jim Hill, Paul Krause, Dan Litzner, Bucky McPhee, Diane Patrick. Absent: None.

**Agenda Approval** – It was moved by Commissioner Krause with support by Commissioner Hill to accept the amended agenda. VVMC

**Approval of Minutes** – It was moved by Commissioner McPhee second by Commissioner Hill to approve the amended minutes of March 8, 2018. VVMC

# **Elected Officials/Staff Reports:**

**Treasurer Goudreau** informed the board that the easement at the old hospital has been taken care of, settlements are completed, and tax foreclosure will be April  $2^{nd}$ .

**Undersheriff Ed Wilk** requested a signature from the board for the Federal Forest Grant in the amount of \$3,000. Undersheriff Wilk informed the board that MDOT presented a certificate to the Mackinac County Sheriff's Inmate Work Program run by 511 Officer Robert St. Louis. (Certificate attached)

**Equalization Director Chipman** informed the board that Equalization is scheduled for April 12. Director Chipman informed the board that she will be advertising for the open position in her office and requested to post for not only an Equalization Clerk but for an Appraiser also. If an Appraiser is interested in the position the pay may increase to approximately \$2,500. The board agreed to post for Equalization Clerk and/or Appraiser.

## Old Business:

**St. Ignace Little Bear Park – Scott** Marshall presented the board with a Little Bear East Park Project Status report and gave a presentation on the progress to date. (Status report attached)

**Security Upgrades/Oak City Proposal** – The board reviewed a proposal from Oak City in the amount of \$26,450 to improve the jail cell intercom, fire alarm for the courthouse, panic alarms, and additional courtroom security cameras. The board tabled this discussion. (Proposal attached)

**Lighting Upgrade/Sheriff Warehouse** – The board reviewed a letter from Sheriff Strait requesting lighting upgrades for the Huskey building in the amount of \$1,500. It was moved by Commissioner Hill second by Commissioner Litzner to approve the lighting upgrades for the warehouse. VVMC (Letter attached)

**Sheriff Copier Proposal** – The board reviewed a letter from Sheriff Strait requesting a copier. It was moved by Commissioner Hill second by Commissioner Litzner to approve the purchase of a BizhubC258 copier for the Sheriff's department in the amount of \$4,314.63 including a guaranteed annual maintenance fee of \$927 based on 103,000 prints. Renewal of Keeper of the Morgue Contract – The board reviewed an Agreement for "Keeper of the Morgue" with Bruce Dodson. It was moved by Commissioner Hill second by Commissioner Litzner to approve the "Keeper of the Morgue" contract for a period of two years expiring on December 31, 2019 in the amount of \$18,639.82 per year.
