MACKINAC COUNTY BOARD OF COMMISSIONERS PROCEEDINGS

January 12, 2017

The Mackinac County Board of Commissioners held their regular meeting on Thursday, January 12, 2017 in the County Annex Building Board Room, 100 S. Marley St., St. Ignace, MI.

Roll Call: Jim Hill, Paul Krause, Dan Litzner, Bucky McPhee, Diane Patrick. Absent: None.

The meeting was called to order by Chairman Hill at 4:33 pm.

The Pledge of Allegiance of the United States of America was recited.

Agenda Approval –Additions: Cell on Wheels and Mackinac County Canvasser appointment. Deletions: Pam Chipman, Equalization and Les Therrian, water main project. It was moved by Commissioner McPhee with support by Commissioner Krause to approve the agenda as amended. VVMC.

Approval of Minutes - It was moved by Commissioner Patrick with support by Commissioner McPhee to approve the minutes of December 22, 2016 as amended. It was moved by Commissioner Krause with support by Commissioner McPhee to approve the minutes of January 5, 2017 as amended. VVMC.

- -Sheriff Scott Strait discussed the purchase of a snowmobile for \$5,700.00 with a trade in of two older snowmobiles. It was moved by Commissioner Patrick with support by Commissioner Krause to purchase the snowmobile in the amount of \$5,700.00 with a trade in of two older snowmobiles for public safety, and to amend the snowmobile budget in the amount of \$5,700.00 for this purchase. - -Equalization Director Pam Chipman informed the board that the equalization studies are in and there is a slight increase in County values. Director Chipman also informed the board that the Michigan Equalization Directors' are working with the State on a retention schedule which should be completed within 7 months.

Business – Mark Wilk discussed the need for an ambulance hall generator. The County's generator currently located in Evergreen Shores is on a trailer and could be utilized in case of an emergency. The only cost would be the installation of a transfer switch and the permit fee. The board gave approval to obtain a bid from an electrician for the installation of the transfer switch.

-Becky Paul, Survey & Remonumentation Grant Administrator, requested the appointment of the peer group members for the 2017 grant year. On motion of Commissioner Patrick with support by Commissioner Litzner, the following were appointed Peer Group members for the 2017 grant year: Erik T. Lewicki, P.S., Keith R. Waters, P.S., Larry R. - -District Courtroom/Oak City Contracting bid. The board reviewed the quote from Oak City Contracting to laminate the District Court judge's podium, desk unit, two table tops and to infill the book shelve opening in the amount of \$5,802.00 plus freight.
